Minutes of Meeting Held January 12, 2023

Notice of the time, date, location and agenda of this meeting to the extent then known, was duly published in the district's official newspapers, posted on its official bulletin board and filed with the office of the municipal clerk at least forty-eight hours in advance of this meeting. <u>Call to Order</u>: the meeting was called to order by Commissioner Torres at 6:16 pm. Commissioner Torres read "Open Meetings Act" statement. All participated in the Pledge of Allegiance. A moment of silence was observed.

Roll Call: Commissioners Couceiro, Goldman, Jamison, O'Brien and Torres were present. No commissioners were absent. Board Attorney Braslow was present remotely.

<u>Minutes</u>: Minutes from the December 8, 2022 meeting: Commissioner Couceiro motioned to approve the minutes from the December 8, 2022 meeting, seconded by Commissioner Goldman. Motion passed by majority vote, with Commissioner Torres abstaining due to his absence at that meeting.

<u>Treasurer's Report:</u> The bill list as well as the report (a copy of which is attached to the original minutes and incorporated herein by reference) as of January 8, 2022 was presented and left on table for public review. Commissioner Jamison read the cash balances into the record. Commissioner O'Brien motioned to accept the Treasurer's report and pay the bills, seconded by Commissioner Couceiro.
