WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 12, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The 2025 Budget is increasing \$482,299.51 or 17.5% from 2024. This increase is primarily from voter approved capital appropriations of \$460,000 and a referendum for \$210, 871.08 for Firefighter and Fringe Benefits for those Firefighters.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Fund Balance is decreasing \$10,000 or -3.4% since there is less need to utilized fund balances in 2025. Interest on investments increased \$500 or 50% from increased interest rates. A grant has been included in Grant revenue that has been awarded to the fire district from AFG. Professional Fees increased \$10,000 or 14.3% for additional services needed. Salary and Wages increased due to contractual increases of \$172,991.07 and following is the Fringe Benefits increase of \$87,520.11 or 13.4% which includes payroll taxes and Pension increases. Insurance increased \$10,000 or 12.5% from increased rates. Vehicle Equipment increased \$2,000 or 20% from increase need for equipment. Interest on payments of debt decreased \$2,627.81 or -32.6% from prior voter approved debt from 2022. Continuing education increased \$4,000 or 66.7% from firefighters that would like to finish their fire science degree. Maintenance and Repair increased \$30,000 or 25% from aging vehicles and equipment. Technology Software increased \$20,000 or 100% from increased software to be compliant. Capital appropriations increased \$145,000 or 46% from voter approved Capital including Command Vehicle \$100,000, renovation of bldg including repaving of parking lot \$40,000, AC Units \$70,000 and bay floor refinishing \$150,000.

The amount to be raised by taxation will increase \$711,799.51 or 17% from 2024. Restricted Fund balance of \$300,000 is being used to offset the budgeted Capital. The district is in compliance with the Levy Cap.

Yes. The district has a severe decrease in volunteer support and the referendum will be used to hire 3 new firefighters to help protect the residents of Jackson Township Distirct 4. Salaries and Benefits totaling \$210, 871.08 are included in the 2025 budget referendum.
