The 2026 Budget is increasing \$1,523,994.44 or 47.1% from 2025. This increase is primarily from capital of \$740,000 and Health Benefits increase of \$395,045.12 or 136.6%.

Restricted Fund Balance is decreasing \$180,000 or -60%. Operating Grant Revenue/Covid is increasing \$60,000 or 100% and AFG is decreasing \$60,000 or -100%, Professional Fees increased \$20,000 or 25% from increased labor law services, Salaries and Wages increased \$472,859.53 or 47.7% from adding 2 new firefighters, Fringe Benefits increased \$433,584.48 or 58.6% from a 36.2% increase in health benefits and corresponding payroll taxes from 2 new firefighters, Insurance increased \$10,000 or 11.1% from increased rates, office expense decreased \$5,316.57 or -38% from a need to reduce the 2026 budget, Outside services increased \$500.00 or 16.7% from needed secretarial services, Payroll expense increased \$6,000 or 100% due to not being budgeted in past budgets, Maintenance and Repair increased \$25,000 or 16.7% from increased need to aging equipment, Supplies increased \$10,000 or 28.6% from higher costs in supplies and need, gear increased \$60,000 or 150% from increased need to outfit new firefighters, Training increased \$5,000 or 20% from increased training needed for new firefighters, Replacement equipment increased \$5,000 or 12.5% from increased need, Technology-Equipment increased \$10,000 or 100% for the need of updated computer equipment, Physicals increased \$15,000 or 100% to add the expense for annual physicals, Uniforms increased \$20,000 or 100% due to increased Firefighters and outdated uniforms, Non-Bondables increased \$4,000 or 13.3% from increased need for training harnesses of \$4,000, Appropriations offset with revenue decreased \$550 or -19.6% from decreased need in replacement equipment, Cash Deficit from preceding year increased \$147,917 or 100% from Overtime that exceeded the expense, Capital appropriations increased \$280,000 or 60.9% from voter approved capital, interest on debt service decreased \$2,688.25 or -49.9%.

The amount to be raised by taxation will increase \$1,703,994.44 or 60.1% from 2025. Restricted Fund Balance of \$120,000 is being used to offset the budgeted 2026 capital. The district is in compliance with the Levy Cap.

Yes. The district has a severe decrease in volunteer support and the referendum will be used to hire 2 new firefighters to help protect the residents of Jackson Township Fire District No 4. Salaries and Benefits are increasing \$500,000 to include two new firefighters and a 36% increase in health benefits are included in the referendum, \$250,000 for an increase in M&R and Fire Fighting Equipment in the

There is no new debt service in 2026. Voter approved appropriations of \$440,000 including Building improvements of Septic \$125,00 and Parking Lot improvement of \$165,000, SCBA of \$100,000 and Gear/Harnesses of \$50,0000. Future Capital of \$300,000 was also included in the 2026 Budget. Debt Service of \$119,000 principle and \$2,750.09 interest on debt are in the 2026 budget from prior approval from 2022.

Yes a Cash Deficit of \$147,917 or 100% is included from the 2024 Audit from a deficit in Overtime. The 2024 year gave challenges to the district with less coverage from the volunteers and increased need for career firefighters. This caused extensive overtime to the district. The 2026 budget includes two new firefighters to correct this deficit.
